COMPOSITION OF STATE TEAMS:

Open:

• top 6 men and top 6 women with the highest total scratch pinfall at the conclusion of 16 games

Classic:

• top 3 men and top 3 women with the highest total scratch pinfall at the conclusion of 16 games.

Restricted:

• top 6 men and top 6 women with the highest scratch pinfall plus handicap at the conclusion of 16 games.

Any tie for the last qualifying position will result in a one (1) game roll off.

NB: Should any exemptions for state team trials be granted, the team involved with the exemption composition will revert to (Open or Restricted) - top 4 men, top 4 women with the 5th and 6th bowlers being determined by a State Team Selection panel. (Classic) – top 2 men, top 2 women with the 3rd bowler being determined by a State Team Selection panel.

ELIGIBILITY:

- Must be a current member of ATBSOV Inc., must be a 2025 TBA registered player and must reside in the state of Victoria (including Albury) as at 31st January 2025.
- Must have completed at least five (5) ATBSOV monthly events from 30th April 2024 to 25th April 2025. New members (joined in January 2025) must have bowled three (3) ATBSOV monthly tournaments by 25th April 2025.
- Restricted Team trial is open to men with a 179 average or lower and women with a 169 average or lower.
- Classic team trial is open to men with a 199 average or lower and women with a 189 average or lower.

TOURNAMENT RULES:

- This is a TBA accredited tournament and all TBA and ATBSOV rules and regulations apply.
- **Dress Code:** As this is an ATBSOV tournament, all bowlers are required to wear their seniors or a state shirt.
- Bowlers may only nominate for one division.
- Five (5) minutes practice will be permitted before commencement of play.
- The TBA no smoking rule will apply; which includes when lane changes are made.
- Any matter not covered; will be decided by the Tournament Committee, whose decision will be final.

FORMAT:

Entry Fee: \$300.00 (payable at check-in)

Day 1 - Saturday 26th April – Frankston - Check in by 8.15am – Lanes on warm up at 8.40am All bowlers will bowl 8 games.

Day 2 – Sunday 27th April – Keon Park – Lanes on warm up at 8.40am All bowlers will bowl 8 games.

At the completion of bowling on day 2; teams will be announced.

Upon selection:

- Team members will receive: 2 shirts, all events entry in ATBSO Nationals, challenge event lineage and lunch on challenge tournament days.
- For any organized fundraising, the money will be divided equally among all team members who participated.
- All team members must attend all arranged team functions, meetings and practice sessions.
- Team members may be required to pay in the vicinity of \$150.00 towards costs.
- Team members must complete an all events entry in the 2025 ATBSO National championships before the interstate challenge commences.
